If third-party verification is not available, owners must document the tenant file to explain why third-party verification was not available.

- 1. Military Pay verification form completed by the Military branch verifying monthly source of pay and source of pay;
- Check stubs or earnings statements showing employee's gross pay per pay period and frequency of pay, requires most recent 6-8 consecutive pay stubs – do not use check without stub;
- 3. W-2 forms if applicant has had the same job for at least two years and pay increases can be accurately projected.
